I would like to thank all of our veterans. Without your service to this


great country, we would not be able to have the freedoms we take for granted.

GORDON BOHANAN – Served with the U. S. Navy Seabees in the 1960's.







DALLAS BURNS – Served in the U. S. Marine Corps from 1961 to 1972 where he attained the rank of Major. He spent most of his service with the Marine Expeditionary Force serving in various capacities including Company Commander and Operations Officer. Dallas passed away on March 4, 2021.

ROBERT CARTER – Served in the U. S. Air Force in Communications / Radar as the Air National Guard Facility, McGee Tyson Air Base from 1965 to 1971.

DEWEY CRUEY – Served in the U. S. Army as a Caterpillar Operator in the Motor Pool Division at Fort Dix, New Jersey from 1961 to 1963.

TONY GARDNER – In 1971, while I was in graduate studies at Texas A & M University, signed up for two possible Air Force positions. Both positions were for a fighter pilot. The first was with the regular Air force and the second was with the



Air National Guard. In either case, flying an Air Force F4 Phantom jet in Vietnam. The Air **National Guard** offer came back first and flight training was to start in the Fall. When the time came to begin training, he was informed that they were not training any more pilots for a

while due to the wind down of the Vietnam War. As an alternate position Tony was a position in the Civil Engineers Electrical Section, directly assigned without additional training due to his advanced education in electrical & mechanical engineering. Stationed at Selfridge AFB and was a Tech NCO heading the electrical crew. The "Red Horse" Unit did multiple deployments to many locations, including Alaska, over the years. After completing his five-year active duty commitment, he continued to support the Local Air National Guard Unit through Military History Tours and Air Shows.

DAVE HERMANSON – Served in the U. S. Navy as a Personnelman / Yeoman from 1966 to 1971 (Active Duty) then as an Active Reservist from 1973 until his retirement in 1989. While on active duty he served aboard the Destroyer Tender USS Everglades (AD-24) participating in several deployments including

one to the Mediterranean before being transferred to the Naval Training Center in San Diego. During his service with the Naval Reserves from 1973 to 1989, he was assigned to a unit which was part of the Military Sealift Command. Durng tis time, he was selected four times for Active Duty for Training assignments in Sase-

bo, Japan and on Okinawa.

MIKE MUMLEY – Served in the U. S. Army from 1990 to 2018 first with an Engineer Unit then on to the Marksmanship Team. After a break from Active Duty joined the Vermont Army National Guard as a Calvary Scout being deployed to both Iraq and Afghanistan. When in Afghanistan, my wife and two sons were deployed there as well.

DAVID SHEFFEY – Served in the U. S. Air Force from 1966 to 2009. Stationed at OFFUTT Air Force Base from 1969 to 1974 where he flew NC-135s used to monitor airborne nuclear tests. In 1977, after starting work at Oak Ridge with the Department of Energy, flew KC-135s with the Air National Guard at McGhee Tyson. Activated during Desert Shield and Desert Storm retiring as a Lt. Col. In 1993 ... serving as a pilot for 27 years except for a 4 year break between Active and Reserve Duty.

BOB WITT – Served in the U. S. Army with the 1st Infantry Division at Fort Riley, Kansas from 1963 to 1965

Call to Order: The President, Matt Sartin, called the meeting to order at 6:30PM. He started the meeting thanking the Board for their attendance and condolences on behalf of his son's passing.
